<u>VILLAGE OF HARVEY</u> <u>BY-LAW NO. 80-1</u> <u>BY-LAWS REVISION BY-LAW, 1980</u>

BE IT ENACTED by the Village Council of the Village of Harvey as follows:

- 1. In this By-Law, unless the context otherwise requires:
 - a) "Village" means the Village of Harvey;
 - b) "By-Laws" means the By-Laws of the Village of Harvey and includes the By-Law of its predecessor the Harvey Local Improvement District;
 - c) "Council" means the Village Council of the Village of Harvey;
 - d) "Clerk" means the Village Clerk of the Village of Harvey.
- 2. This By-Law may be cited as the "By-Laws Revision By-Law, 1980".
 - a) The Clerk shall examine the By-Laws and shall prepare a revision and consolidation of the By-Laws.
 - b) The Clerk may engage legal and other professional advice and assistance as he dreams necessary to prepare a revision and consolidation of the Village By-Laws.
- 3. The Clerk, in preparing the revision and consolidation of the By-Laws may;
 - a) omit any By-Law or any part thereof that is repealed or spent or that for any reason he considers advisable to omit;
 - b) alter the numbering or arrangement of any statute or of any provision thereof;
 - c) make such alterations in language as are necessary to preserve uniform mode of expression in the By-Law;

- d) make such amendments as are necessary to express more clearly what is deemed to be the intention of the Council, or to reconcile seemingly inconsistent enactments, or to correct clerical or typographical errors;
- e) make such amendment as the Clerk deems desirable to update and improve the effect and enforceability of the By-Laws;
- f) provide the repeal of any By-Law in whole or in part that is deemed to be obsolete, or to be superseded by, or inconsistent with any By-Law to be included in the consolidation and revision, and
- g) Include any new By-Law the Clerk deems to be desirable to better secure the peace, order and good government for the Village.
- 4. Council may adopt and enact the revision and consolidation, or any variation thereof that the Council deems desirable, as a By-Law of the Village to be designated as the "Revised By-Laws of the Village of Harvey, 1980".
- 5. If upon any point the provisions of the Revised By-Laws of the Village of Harvey, 1980 are not in effect the same time as those of the repealed By-Laws and parts of the By-Laws for which they are substituted, then as respects all transaction, matters and things subsequent to the enactment of the Revised By-Laws of the Village of Harvey, 1980, the provisions contained in them shall prevail, but as respects all transaction, matters, and things anterior to that time, the provisions of the repealed By-Laws and parts of By-Laws prevail.
- 6. A reference in any By-Law enacted prior to the enactment of the Revised By-Laws of the Village of Harvey, 1980 and remaining in the force after that time, or in any resolution, instrument or document to any By-Law or any part of the By-Law repealed by the Revised By-Laws of the Village of Harvey, 1980, be held, as regards any subsequent transaction, matter or thing, to be reference to the enactments in said Revised By-Laws of the Village of Harvey, 1980 that have the same effect as repealed By-Law or part of a By-Law.

This original By-Law is filed at the Harvey Village Office under By-Laws in alphabetical order
